FLERE LAG STEVNE STEERING COMMITTEE BYLAWS

Article I - Name

The name of the organization shall be "Flere Lag Stevne Steering Committee," or FLSSC.

Article II - Purpose

The FLSSC is established for the expressed purpose of planning and conducting stevner for the members of the Gudbrandsdalslaget, Nord Hedmark og Hedemarken Lag, Romerikslag, Solør Lag of America, and Trønderlag of America.

Article III - Membership

Each member lag shall have two voting members on the FLSSC.

Article IV - Officers

- 1. The officers of the FLSSC shall consist of a chairperson, vice chairperson, secretary, and treasurer. They shall be elected by the FLSSC at the first annual meeting each year.
- 2. The Chairperson shall preside at all meetings of the FLSSC. The Chairperson shall have the power to appoint all committee chairpersons, shall present motions to the body present, and shall be present at 66% of the meetings of the FLSSC.
- 3. The FLSSC shall elect a Vice Chairperson. The Vice Chairperson shall preside at all meetings and functions that the Chairperson cannot attend.
- 4. The FLSSC shall elect a Secretary who will record and maintain a record of the minutes of each meeting.
- 5. The FLSSC shall elect a Treasurer who will handle all financial affairs and maintain a record of all financial transactions of the FLSSC.

Article V - Meetings

The FLSSC shall meet in the fall, winter, and spring. Other meetings shall be held at the discretion of the officers or at the request of a majority of the members.

Article VI - Decisions

Decisions of the FLSSC shall be by a majority rule of the voting members present. The FLSSC shall have the power to make all decisions necessary for planning and conducting stevner.

Article VII - Finances

The FLSSC shall establish fees for each stevne which are sufficient to cover all expenses. Excess stevne expenses shall be assessed to members lags based on the number of registered attendees from each lag. A similar process shall be followed in distributing excess profits.

Article VIII - Committees

The FLSSC shall have the power to establish committees and assign coordinators necessary for planning and conducting each stevne and shall define the scope of their responsibilities. Each committee shall submit on an annual basis a report of its activities for the year at the first meeting following the stevne.

Article IX - Changing the Bylaws

The FLSSC shall have the power to change the bylaws when deemed necessary. Proposals for amending the bylaws shall be introduced at one meeting and approved at the next meeting by a two-thirds vote of the members.

Article X - Annual Audit

The financial records of the FLSSC shall be audited annually by an independent committee appointed by the Chairperson. The audit report shall be submitted to the FLSSC by December 31 following the stevne.

Article XI - Ratification

The bylaws shall become the governing document of the FLSSC upon approval of a two-thirds majority of the FLSSC.
